Advance Notice was simultaneously given to the Chairman and all members of the Board of Trustees and their acknowledgment of receipt of Notice and the agenda are affixed to these minutes. Chairman Tanner Tool called the meeting to order at 7:00p.m. by calling for the roll with the following members responding: Mike Brown, Kyle Lawrence, Tanner Tool, Davis Miner and Cory Halliwell. Absent: none. Tanner announced that the Open Meeting Laws were in the hallway leading to the meeting room for the public's inspection.

BE IT RESOLVED BY THE CHAIRMAN OF THE BOARD OF TRUSTEES OF THE VILLAGE OF ELM CREEK, NEBRASKA: That the plat of REICHERT COMMERCIAL ADDITION, an addition to the Village of Elm Creek, Buffalo County, Nebraska for a tract of land being part of the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section Twenty-seven (27), Township Nine (9) North, Range Eighteen (18) West of the Sixth Principal Meridian, Buffalo County, Nebraska, more particularly described as follows: Referring to the Northeast Corner of the Southwest Quarter of the Southwest Quarter of Section 27 and assuming the East line of the Southwest Quarter of the Southwest Quarter of Section 27 as bearing $S 00^{\circ} 52^{\prime} 39^{\prime \prime}$ E and all bearings contained herein are relative thereto; thence on the East line of the Southwest Quarter of the Southwest Quarter of said Section 27, S $00^{\circ} 52^{\prime} 39^{\prime \prime} \mathrm{E}$ a distance of 632.38 feet to a point on the North right-of-way line of U.S. Highway No. 30; thence on the North right-of-way line of U.S. Highway No. 30, N $80^{\circ} 50^{\prime} 52^{\prime \prime}$ W a distance of 707.51 feet to the ACTUAL PLACE OF BEGINNING; thence continuing on the North right-of-way line of U.S. Highway No. 30, N $80^{\circ} 50^{\prime} 52^{\prime \prime}$ W a distance of 268.50 feet; thence continuing on the North right-of-way line of U.S. Highway No. 30, S $01^{\circ} 00^{\prime} 57^{\prime \prime}$ E a distance of 33.38 feet; thence continuing on the North right-of-way line of U.S. Highway No. 30, N $81^{\circ} 07^{\prime} 15^{\prime \prime}$ W a distance of 85.80 feet; thence leaving the North right-ofway line of U.S. Highway No. 30, N $01^{\circ} 06^{\prime} 07^{\prime \prime}$ W a distance of 135.08 feet; thence S $88^{\circ} 28^{\prime} 14^{\prime \prime}$ E a distance of 12.56 feet; thence $\mathrm{N} 01^{\circ} 06^{\prime} 07^{\prime \prime}$ W a distance of 49.46 feet to a point of curvature; thence on
a 508.0 foot radius curve to the right forming a central angle of $10^{\circ} 07^{\prime} 21^{\prime \prime}$ an arc distance of 89.75 feet to a point on a 50.0 foot radius non-tangent curve, concave southerly; thence on said non-tangent curve, in a clockwise direction, forming a central angle of $286^{\circ} 11^{\prime} 05^{\prime \prime}$ an arc distance of 249.74 feet to a point on a non-tangent curve, said point bears $\mathrm{S} 78^{\circ} 43^{\prime} 35^{\prime \prime} \mathrm{E}$ a chord distance of 60.05 feet from the previously described point; thence southerly on a 448.0 foot radius non-tangent curve to the left forming a central angle of $03^{\circ} 11^{\prime} 52^{\prime \prime}$ an arc distance of 25.00 feet to a point of non-tangency, said point bears $\mathrm{S} 07^{\circ} 07^{\prime} 11^{\prime \prime} \mathrm{W}$ a chord distance of 25.00 feet from the previously described point; thence leaving said curve, non-tangent, $\mathrm{S} 80^{\circ} 50^{\prime} 52^{\prime \prime} \mathrm{E}$, parallel with the North right-of-way line of U.S.
Highway No. 30, a distance of 277.66 feet; thence $S 01^{\circ} 06^{\prime} 07$ " E a distance of 215.50 feet to the place of beginning, containing 1.98 acres, more or less, duly made out, acknowledged and certified, and the same hereby is approved, accepted and ordered, filed and recorded in the Office of the Register of Deeds of Buffalo County, Nebraska, and hereafter said subdivision shall be and remain a part of the Village of Elm Creek, Nebraska, and shall be included within the corporate limits of said Village and shall be and become a part of said Village for all purposes whatsoever, and the inhabitants of such addition shall be entitled to all the rights and privileges and shall be subject to all laws, ordinances, rules and regulations of said village.

## ORDINANCE NO. 2019-12

AN ORDINANCE OF THE VILLAGE OF ELM CREEK, BUFFALO COUNTY, NEBRASKA, CHANGING A CERTAIN ZONING AREA WITHIN THE VILLAGE; PROVIDING FOR CHANGES TO THE ZONING MAP; PROVIDING AN EFFECTIVE DATE; AND REPEALING ALL ORDINANCES IN CONFLICT.

## BE IT ORDAINED BY THE CHAIRPERSON AND BOARD OF TRUSTEES OF THE VILLAGE OF ELM CREEK, NEBRASKA:

SECTION 1. That pursuant to the recommendation of the Elm Creek Planning Commission, the following-described property, to-wit:

A tract of land being part of the Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section Twenty-seven (27), Township Nine (9) North, Range Eighteen (18) West of the Sixth Principal Meridian, Buffalo County, Nebraska, more particularly described as follows: Referring to the Northeast Corner of the Southwest Quarter of the Southwest Quarter of Section 27 and assuming the East line of the Southwest Quarter of the Southwest Quarter of Section 27 as bearing $S 00^{\circ} 52^{\prime} 39^{\prime \prime} \mathrm{E}$ and all bearings contained herein are relative thereto; thence on the East line of the Southwest Quarter of the Southwest Quarter of said Section 27, S $00^{\circ} 52^{\prime} 39^{\prime \prime} \mathrm{E}$ a distance of 632.38 feet to a point on the North right-of-way line of U.S. Highway No. 30; thence on the North right-of-way line of U.S. Highway No. 30, N $80^{\circ} 50^{\prime} 52^{\prime \prime}$ W a distance of 707.51 feet to the ACTUAL PLACE OF BEGINNING; thence continuing on the North right-of-way line of U.S. Highway No. 30, N $80^{\circ} 50^{\prime} 52^{\prime \prime} \mathrm{W}$ a distance of 268.50 feet; thence continuing on the North right-of-way line of U.S. Highway No. 30, S $01^{\circ} 00^{\prime} 57^{\prime \prime}$ E a distance of 33.38 feet; thence continuing on the North right-of-way line of U.S. Highway No. 30, N $81^{\circ} 07^{\prime} 15^{\prime \prime} \mathrm{W}$ a distance of 85.80 feet; thence leaving the North right-of-way line of U.S. Highway No. 30, N $01^{\circ} 06^{\prime} 07^{\prime \prime} \mathrm{W}$ a distance of 135.08 feet; thence $\mathrm{S} 88^{\circ} 28^{\prime} 14^{\prime \prime} \mathrm{E}$ a distance of 12.56 feet; thence $\mathrm{N} 01^{\circ} 06^{\prime} 07^{\prime \prime} \mathrm{W}$ a distance of 49.46 feet to a point of curvature; thence on a 508.0 foot radius curve to the right forming a central angle of $10^{\circ} 07^{\prime} 21^{\prime \prime}$ an arc distance of 89.75 feet to a point on a 50.0 foot radius nontangent curve, concave southerly; thence on said non-tangent curve, in a clockwise direction, forming a central angle of $286^{\circ} 11^{\prime} 05^{\prime \prime}$ an arc distance of 249.74 feet to a point on a non-tangent curve, said point bears $S 78^{\circ} 43^{\prime} 35^{\prime \prime} \mathrm{E}$ a chord distance of 60.05 feet from the previously described point; thence southerly on a 448.0 foot radius non-tangent curve to the left forming a central angle of $03^{\circ} 11^{\prime} 52^{\prime \prime}$ an arc distance of 25.00 feet to a point of non-tangency, said point bears $S 07^{\circ} 07^{\prime} 11^{\prime \prime} \mathrm{W}$ a chord distance of 25.00 feet from the previously described point; thence leaving said curve, non-tangent, $S 80^{\circ} 50^{\prime} 52^{\prime \prime} \mathrm{E}$, parallel with the North right-of-way line of U.S. Highway No. 30, a distance of 277.66 feet; thence $S 01^{\circ} 06^{\prime} 07^{\prime \prime}$ E a distance of 215.50 feet to the place of beginning. Containing 1.98 acres, more or less, now known as REICHERT COMMERCIAL ADDITION (described hereinafter as "Real Estate")
shall hereinafter be designated as General Commercial District (C-2) subject to the restrictions and limitations stated herein and shall be governed by the General Commercial District regulations of the official Zoning Ordinance of the Village.

SECTION 2. That the Official Zoning Map of the Village of Elm Creek, Nebraska, hereby ordered to be changed, amended, and completed in accordance with this ordinance.

SECTION 3. That this ordinance shall be in force and take effect from and after its passage, approval and publication as provided by law.

SECTION 4. That any ordinances in conflict herewith are hereby repealed.
