RESOLUTION NO. 2021-8

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the Village of Elm Creek passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of the Village of Elm Creek, Nebraska, resolves that:

1. The 2021-2022 property tax request be set at:

General Fund: \$232,805.00

Bond Fund: \$ -

- 2. The total assessed value of property differs from last year's total assessed value by 1.55 percent.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be 0.369048 per \$100 of assessed value.
- 4. The Village of Elm Creek proposes to adopt a property tax request that will cause its tax rate to be 0.378203 per \$100 of assessed value.
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the Village of Elm Creek will increase from last year's budget by 12.43 percent.
