DOG LICENSING

Elm Creek Village Ordinance requires that all dogs over four months old and living within the Village shall be licensed annually. License renewal is on or before May 1 each year regardless of when you licensed your dog(s) the year Please stop by the before. Village Office to license your dog(s). A certificate that the dog has had a rabies shot, effective for the ensuing year of the license, shall be presented when the license is applied for, and no license or tag shall be issued until the certificate is shown. The license fee is \$3.50 per dog.

GOLF CART, ATV/UTV ORDINANCE

In order to be authorized for operation on the streets and highways of the Village of Elm Creek, <u>ALL</u> <u>golf cart, ATV and UTV vehicles</u> will need to be <u>registered annually</u> with the Village of Elm Creek and owners are required to have proof of liability insurance coverage for the golf cart. <u>Operators should</u> <u>be 16yrs old and hold a valid Nebraska drivers license</u>. A copy of the ordinance can be picked up at the Village Office or view it on the village website. Please read this Ordinance carefully, because should you not comply with the regulations, there will be a 'Fine' imposed. <u>2023 valid permits are January 1 through</u> <u>December 31</u>. Golf cart, ATV and UTV vehicles may be operated on the streets and highways within the corporate limits of the Village of Elm Creek <u>only</u> if such vehicle is equipped with the following: working headlights, tail lights, brake light(s), an OEM muffler, and a federally approved bicycle safety flag attached to the rear of the vehicle and when attached to the vehicle extends not less than five (5) feet above ground. Golf carts, ATVs and UTVs may only be operated between the hours of dawn to dusk.
